Old Business

1. Township Engineer John Klinedinst provided a presentation to the Board regarding ideas for the new highway building. Mr. Klinedinst is proposing a 15,880 sq. ft. structure with separate heating zones between the office, shop and garage area. The structure will be block wall and wood trusses for the office and shop area and pole barn for the garage. The estimated cost of construction/permits etc. would be 1.45 million. Motion by Supervisor Kellner, seconded by Supervisor Schock to proceed with obtaining pricing on the original layout and prepare bids. The Board also asked Mr. Klinedinst to get pricing on additional bays of 20 ft and 40 ft. Motion carried 3-0.

New Business

- East Prospect Fire Co Loan Agreement Upon a motion by Supervisor Kellner, seconded by Supervisor Schock, the 3 year loan agreement and note for the East Prospect Fire Company were approved in the amount of \$80,000.00 at 2% interest. Motion carried 3-0.
- 2013 Tax Exonerations Upon a motion by Supervisor Schock, seconded by Supervisor Kellner, the per capita tax exonerations were approved. Motion carried 3-0.
- MANAGER REPORT Ms. Hartman submitted her report for review. Ms. Hartman also updated the Board on the York Water Company's acquisition of the East Prospect Authority. Motion by Supervisor Kellner, seconded by Supervisor Schock to direct Mr. Klinedinst and Atty. Herrold to draft a change to the SALDO regarding mandatory hookup for residents. The Board expressed that they approve of the proposed service territory for York Water Company's acquisition, as outlined on the map. As a follow up to resident Becky Pfeiffer speaking as a patron at the December meeting, Ms. Hartman stated that on December 17, she and Sande Cunningham met with Code Administrators representatives to discuss Ms. Pfeiffer's issues. On January 2, Norm Strenger from Code Administrators and Sande and Maureen met together with Ms. Pfeiffer. Mr. Strenger explained that some of the requirements had not been needed as previously discussed with her and that the requirements had nothing to do with Lower Windsor Township, but was instead state-mandated code requirements. Mr. Strenger and Ms. Pfeiffer went back to her business to go over everything together. Staff has not heard from Ms. Pfeiffer since that meeting. Ms, Hartman advised the Board that staff found a used 2008 Jeep Liberty with 44,000 miles for \$13,393,50 and is asking for approval to purchase the vehicle. Motion by Supervisor Kellner, seconded by Supervisor Schock to approve the purchase of the 2008 Jeep Liberty, motion carried. 3-0. Ms. Hartman asked the Board to sign off on the Proof of Loss document for the building since they are aware of the estimated cost of the new building. Motion by Supervisor Kellner, seconded by Supervisor Schock to approve the execution of the document, motion carried. 3-0. Ms. Hartman noted that we have received 3 trucks as of today.

Approval of Bills – Upon a motion by Supervisor Kellner, seconded by Supervisor Schock, the bills as listed in the amount of \$21,479.93 were approved. Motion carried 3-0.
