- 1. APPROVAL OF MINUTES DECEMBER 14, 2017: Motion by Supervisor Schock, seconded by Supervisor Kellner to approve the minutes with an amendment to note the document submitted from Casey Smith for approval was for the CAD Web View User Agreement, motion carried. Chairman Miller abstained.
- 2. PROMOTION OF CORPORAL THOMAS TO SERGEANT: Chief Caldwell promoted Cpl. Thomas to the position of Sergeant.
- 3. REPORTS:
 - a. MANAGERS REPORT: Ms. Cunningham submitted her report for review.
 - i. Ms. Cunningham noted that the PSATS convention will be held April 22-25, 2018.
 - ii. Ms. Cunningham informed the Board that we received a quote for 2 controllers for the heating system. The cost is \$3,500.00. Motion by Supervisor Kellner, seconded by Supervisor Schock, to approve the quote from Griffith Automation for the 2 controllers in the amount of \$3,500.00 motion carried.
 - iii. Ms. Cunningham noted that there was an issue with one of the police vehicles that Chief Caldwell can expand on. Chief Caldwell informed the Board that one of the vehicles is having issues with transmission fluid leaking and can be repaired for \$500, but since this is one that will be traded in for a new vehicle he is asking for authorization to get the vehicle fixed. By consensus, the Board agreed to repair the vehicle.
 - b. ENGINEER: Mr. Klinedinst submitted his report for review. Mr. Klinedinst also noted that he has not heard from the York Water Company on the amended agreement. Mr. Klinedinst also reported that he attended a webinar on ADA transition plans and recommends the Board look into ADA inventory/assessment for the Township. The Board asked Ms. Cunningham to look into this to discuss at a future meeting.
 - c. EMERGENCY SERVICES: Lake Clarke Rescue and CVAC submitted their reports.
- 4. ZONING:
 - a. Inter-Municipal Comprehensive Plan: Ms. Love provided the Board with a memo regarding Inter-Municipal Comprehensive Plan to work with Hellam Township, Hallam Borough, East Prospect Borough, Wrightsville Borough and Yorkana Borough and asked if the Board would be interested in moving forward. The Board is interested in exploring this option.
 - b. Zoning Hearing: Ms. Love informed the Board that a case is before the Zoning Hearing Board that would be of interest to the Board and is asking for authorization to have the Township Solicitor attend. The Board agreed to have either Solicitor John Herrold or Engineer John Klinedinst attend the Zoning Hearing Board meeting.

- 6. NEW BUSINESS: Chairman Miller announced that we have an opening in the Highway Department and would like to hire a new employee. Motion by Supervisor Kellner, seconded by Supervisor Schock to authorize Ms. Cunningham and Kim Miller to work on advertising the position and provide a candidate list to the Board.
 - a. APPROVAL OF BILLS: Motion by Supervisor Schock, seconded by Supervisor Kellner to approve the bills as listed in the amount of \$18,669.00, motion carried.
 - b. OTHER PERTINENT BUSINESS: Supervisor Kellner motioned to approve the CAD Web View User Agreement for Craley Fire Company, seconded by Supervisor Schock, motion carried.
