## ZONING:

- SUBDIVISION PLAN 610-20SLD RIVER RIDGE HILLS: River Ridge Hills developer is requesting a modification of the construction material & specification manual. They want to use a 2" 3A stone base with an 8" layer of Aashto #1. C S Davidson is modifying their request and recommending a 10" of road base and 3.5" binder course and 2" of wearing course. If the Board approves this modification, C S Davidson will make change to the construction materials & specification manual as well. Motion by Supervisor Yakubowski, seconded by Supervisor Rohrbaugh to approve the recommended modifications by C. S. Davidson, motion carried.
- ON LOT SEPTIC PUMPING & INSPECTION EXTENTION 1181 KNIGHTS VIEW ROAD: Motion by Supervisor Yakubowski, seconded by Supervisor Rohrbaugh to approve the extension till March 2023, motion carried.

## OLD BUSINESS:

- TRAFFIC LIGHTS FOR CRALEY FIRE COMPANY: C S Davidson received a quote of \$22,155 which does not include the sign. The Board discussed the funding of this project. Grant money may be available. Ms. Cirilo from the Rec Authority may be able to help. Supervisor Rohrbaugh questioned the donation to Yorkana Fire Co. that we may re-allocate their donation. Supervisor Yakubowski met with a Yorkana Fire Co member and provided information on their discussion. The donation to Yorkana Fire Co will be tabled till the February meeting.
- SALT SHED APPLICATION FOR PAYMENT: Motion by Supervisor Yakubowski, seconded by Supervisor Rohrbaugh to approve the payment of \$27,859.72 to Lauer Construction Services, motion carried. We will be holding a retainage of \$1,500 for repair of the yard.
