

LEAVE NOTHING BUT FOOTPRINTS BEHIND...

The Susquehanna River is an important and integral part of the character of Lower Windsor Township and the surrounding communities. It has shaped the lives of residents and visitors alike for generations. Fishing, boating, and other recreation is enjoyed throughout the year, but it is imperative that users of the river take responsibility for its quality and that of the downstream waters.

Again in 2023 the ice floes came up past the banks and swept away tables and chairs, firewood, gas grills, propane tanks and all manner of debris down to the dam. We must be better stewards of our natural resources. The Township has been working with lease holders and property owners to remove buoyant and hazardous items from the riverfront properties, and to anchor items that are stored on-site. We still have a long way to go.

The Lower Windsor Floodplain Ordinance (first adopted in 1983 and twice revised) requires all properties located within the Special Flood Hazard Area (SFHA) to obtain permits when improvements are made, **regardless** of whether the improvements meet the requirements of the Uniform Construction Code or the Township Zoning Ordinance for permit obligation.

Improvements to existing structures in the floodplain without a permit are a violation of the Floodplain Ordinance.

Disturbance to the floodplain without a permit is a violation of the Floodplain Ordinance.

Disturbance to the FLOODWAY of a stream or the Susquehanna River first requires a permit from PA DEP. Once PA DEP has issued a permit, an application may be submitted to the Township. DEP's approval of a project does not mean you will automatically get a permit from the Township.

Lower Windsor is mandated by federal law to implement the Floodplain Ordinance. Staff meet with FEMA personnel on a regular basis to report our progress in resolving the Community Action Visit (CAV). Failure to do so jeopardizes federal flood insurance for all property owners in the Township. FEMA has directed that all issues noted in the CAV be completely resolved by December 31, 2023. Residents who refuse to comply may receive a citation, in accordance with Section 235-16 of the Lower Windsor Township Codified ordinances, which provides for fines and penalties, including a summary filing at the District Magistrate. Hop Aboard Rabbittransit Shared Ride

Getting around shouldn't be a challenge! Whether you want to run errands, attend medical appointments, join recreational activities, or visit friends, there's an easy way to get there: Book a Shared Ride with Rabbittransit.

Unlike a scheduled bus route that only operates in one area, Shared Ride (a.k.a. Paratransit) provides consolidated trips between travel origins and destinations during limited hours and specific areas.

All Shared Ride trips require a reservation. If you would like same-day service, you must make your reservation by 1:30 p.m. Otherwise, reservations must be made no later than 12:00 p.m. the business day before your ride. Reservations may be made two weeks in advance. For trips on Saturday, Sunday or Monday, reservations must be submitted by 12 p.m. the Friday before. Visit www.rabbittransit.org > Shared Ride > Reservations to schedule a reservation.

When making a reservation for Shared Ride, it's essential to plan accordingly since the service accommodates other passengers' travel plans. Riders are grouped together based on their travel time and location(s). Travel times may be shorter or longer, depending on the total number of riders at the time. While ride times may vary, Shared Ride is a reliable and safe transportation option that can give you peace of mind when accessing life-sustaining services.

If Shared Ride sounds like a fit for you, the first step is to submit an application to the program you'd like to participate in. Shared Ride programs vary from Senior Shared Ride to the Medical Assistance Transportation Program (MATP), ADA Complementary Paratransit

Catholic Harvest Mobile Pantry



Catholic Harvest Mobile Food Pantry is holding food distribution events at Lower Windsor Township in the lower level parking lot.

The first event was held on July 13th and was a success. They served 28 families in a one hour time period. On Aug. 10th, Catholic Harvest returned to serve 26 more families. Any new

households should reach out to them no later than Monday, Sept. 11th, if they wish to be included in the Mobile Distribution for September. If you call Catholic Harvest Food Pantry at 717-846-8571 and press option 3, they can get your information. This will include your name, address, phone number, as well as the names and dates of birth of all household members. Please email Catholic Harvest to ask about Food Stamps/SNAP so they can make sure that you financially qualify. On Tues., Sept. 12, Catholic Harvest will update the list of food offerings and begin reaching out to the households (by phone, email or text) who are signed up for the Mobile Pantry run to Lower Windsor Township. They will also contact any new households to get their food lists and will try to have all of the lists compiled by Wed. September 13th. Catholic Harvest will then pack each order Thursday morning and deliver to LWT Susquehanna Area Senior Center parking lot.

Future Mobile Food Pantries will be held on the second Thursday of the following months from 10:30Am—11:30AM., Sept. 14th, October 12th, November 9th, and December 14th. Anyone who needs food assistance may register by calling 717-846-8571, option 3. Households **MUST** pre-register at www.catholicharvest.org.

Can Emergency Services see your Building Number?

In 2008 the Board of Supervisors passed an Ordinance requiring all buildings to post and maintain the street number on the building. These numbers must be no less than 4" high and of contrasting color and located so they are visible from the road. Reflective is best.

On buildings more than 100 ft from the road or where landscaping conceals them, the numbers must be posted at the end of the driveway nearest the road. Where more than one building is located along a private road or access drive, each address must be posted at the entrance of the street **and** at each individual drive or front yard.

When to call 911

Always call 9-1-1 in the event of a true emergency (burglary, traffic accident, assault, kidnapping, missing person, suspicious vehicles or people, etc). If you call the general office phone number of the LWTPD in the event of an emergency, you may not get an immediate response due to our officers being out on patrol.

Several people do not think they have a true emergency and don't want to bother dispatchers and police after hours and on the weekends. However, that's how you get police responses on the weekends and after hours. Officers are patrolling during these times and the dispatchers have direct communication with patrol officers.

Zoning Department

Zoning Permits

Zoning Permits are required for carports, garages and sheds NOT attached to your house; porches, patios, paver patios, sidewalks and walkways; decks that are no higher than 30" from the ground, widening a driveway or parking area (whether it's new paving or stone). Also, any work that changes the ground within the floodplain requires a permit...ANY work.

Permits

Lower Windsor Township requires permits for many types of construction and building work. Some jobs require only a 'Zoning Permit' and other jobs will require a 'Building Permit'. These are separate permits which now use the same application form.

Zoning permits fall under Township rules and Ordinances. Building Permits are governed by the Pennsylvania Uniform Construction Code and will require inspections during the work. Zoning Permits are issued within 10 business days and Building Permits require 15 business days.

There is only one permit application to fill out. The permit(s) issued will be Zoning, Building or both. Each permit has different fee requirements, but both are issued from the Township office.

Permit Questions

Building Permits:

Building permits are required for home additions of any type, porch roofs or extensions, new doors or windows where the new ones and old ones are different sizes; changes to the structural integrity of the house (exterior walls, floors, roof trusses, beams and the like); installing a wood burning/pellet stove with a chimney; swimming pools deeper than 24"; non-residential, permanent signs.

Some work requires both zoning & building permits: decks over 30" high, demolition of any structure, new homes and additions; accessory structures over 1,000 square feet; swimming pools with decks and/or patios.

As always – stormwater management is required on your lot for ANY and ALL new impervious surfaces (area that no longer allows rain to seep through). This can be done several different ways which may include rain gardens, seepage beds, or infiltration trenches.

OLDS (On-Lot Disposal System)

Residents in septic pumping District #2 were notified via postcard mailings in January and in July, that 2023 is the year to have their septic systems pumped and inspected by December 31, 2023. If you did not receive a postcard and think you should have, please contact the Township office at 717-244-6813, to verify your pumping district.

District # 2 consists of all properties south of East Prospect Road and Calvary Church Road, and east of Prayer Mission Road and Snyder Corner Road. **Noncompliance WILL result in penalties!**

Tips for Closing your SWIMMING POOL

In an effort to help protect our local waterways and their aquatic life, PA DEP recommends the following when closing your pool for the season.

Discharged pool water and waters containing chlorine or other chemicals can be detrimental to aquatic life if not handled responsibly. It is extremely important that these waters are handled correctly. Pool waters must not be discharged to any storm or sanitary sewer or land in which a storm sewer or stream is accessible. Runoff can cause fish kills and unsafe aquatic conditions.

• Never dispose of pool water through a storm sewer, which will discharge to a stream.

• If lowering the water level of the pool, **STOP CHEMICAL ADDI-TIVES for ONE WEEK PRIOR** and let it drain to a vegetated area to prevent it from running off into a storm sewer or stream. Dissipate the water through a sprinkler or soaker hose to prevent channelization and infiltrate it on **your property**.

• Water may be used for irrigation if it does not run off the property or into a storm sewer, stream, or public roadway.

If you cannot drain the pool in these ways have the water professionally pumped out.

The discharge of swimming pool water to any waters of the commonwealth without a permit is a **violation of the Clean Streams Law.** Property owners and pool companies that violate this law may be prosecuted and penalized for damages.

Top 10 Scams directed at Senior Citizens

1. Health Care/Medicare/Health Insurance Fraud -

Every U.S. citizen or permanent resident over age 65 qualifies for Medicare, so there is rarely any need for a scam artist to research what private health insurance company older people have in order to scam them out of some money.

2. Counterfeit Prescription Drugs - Most commonly, counterfeit drug scams operate on the Internet, the danger is that besides paying money for something that will not help a person's medical condition, victims may purchase unsafe substances that can inflict even more harm.

3. Funeral & Cemetery Scams - One type of common scam is claiming the deceased had an outstanding debt with them, scammers will try to extort money from relatives to settle the fake debts.

4. Fraudulent Anti-Aging Products - Botox scams are particularly unsettling, as renegade labs creating versions of the real thing may still be working with the root ingredient, botulism neurotoxin, which is one of the most toxic substances known to science. A bad batch can have health consequences far beyond wrinkles or drooping neck muscles.

5. Telemarketing - Two of the most common scams are:

"The Fake Accident Ploy" - The con artist gets the victim to wire or send money on the pretense that the person's child or another relative is in the hospital and needs the money.

"Charity Scams" - Money is solicited for fake charities. This often occurs after natural disasters.

6. Internet Fraud - Pop-up browser windows simulating virus-scanning software will fool victims into either downloading a fake anti-virus program (at a substantial cost) or an actual virus that will open up whatever information is on the user's computer to scammers.

7. Investment Schemes - From pyramid schemes like Bernie Madoff's (which counted a number of victims) to fables of a Nigerian prince looking for a partner to claim inheritance money, these schemes have been popular for many years.

8. Homeowner/Reverse Mortgage Scams - the reverse mortgage scam has mushroomed in recent years. With legitimate reverse mortgages increasing in frequency more than 1,300% between 1999 and 2008, scammers are taking advantage of this new popularity.

9. Sweepstakes & Lottery Scams - scammers inform their mark that they have won a lottery or sweepstakes of some kind and need to make some sort of payment to unlock the supposed prize.

10. The Grandparent Scam - fake grandchild will usually ask for money to solve some unexpected financial problem (overdue rent, payment for car repairs, etc.).

Mailbox reminder to Homeowners

Lower Windsor Township reminds homeowners to prepare mailboxes for winter. Snow that is thrown from plows can damage mailboxes if they are not properly prepared and secured. A properly secured and located mailbox should be able to withstand the force of snow thrown from a plow, even in the worst conditions. Mailboxes should be placed as far from the edge of the road as possible yet still in reach of a mail carrier from a vehicle. Mailboxes are normally placed within the Township's legal right-of-way however, mailbox damage due to snow and not hit directly by the plow or truck is the homeowner's responsibility. **Here are a few tips to help reduce mailbox damage:**

- Place reflective tape on the mailbox to help operators see them at night. When removing snow from around the mailbox, throw snow behind it and not to the sides.
- Make sure the post is in good condition and the box is fastened securely to the post
- If damage was experienced in the past, reconsider the positioning and structure before winter.

For those who follow these tips and still find themselves with a damaged mailbox, they may want to consider a cantilever mailbox support that can swing a mailbox out of harm's way. Plans for such a mailbox are available on PennDOT's website, www.penndot.gov/winter.

Snow Removal Policy 2023

With winter soon approaching, the Highway and Police Departments ask that all residents keep these Township tips in mind during inclement weather.

- Avoid parking along Township roads when snow storms are anticipated. If a road is designated a Snow Emergency Route, vehicles must be removed from the roadway when there is three or more inches of snow expected.
- When a snow emergency is declared, Lower Windsor Township utilizes the major local television stations for resident notification.
- As we receive up-to-date information from the National Weather Service, PennDot, and York County Emergency Management, we will post it to our Savvy Citizen app.
- When clearing your driveway, shovel the snow on the lower side of the driveway so that the plow doesn't push it back into the area you have already shoveled.

Winter Weather Tips

The Highway Department will soon be shifting into winter gear. Residents are reminded to be cautious around snow clearing equipment and take the following precautions:

- Avoid passing snow clearing equipment that is in motion. The operators travel at a speed lower than the posted speed limit to operate safely.
- Motorists should not pass snow clearing equipment, as the road conditions in from of the equipment are more hazardous than the conditions behind.
- The snow and spray from the snow plow blades can impede visibility and someone passing might not see the conditions ahead or oncoming traffic.
- Keep a safe distance behind the snow clearing equipment. Longer braking distances are needed in winter.
